The Annual Fund received donations totaling over \$668,000, providing support for current operations and Camperships. 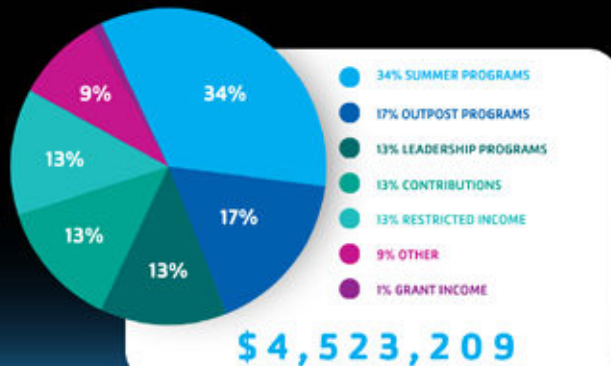

FINANCIALS

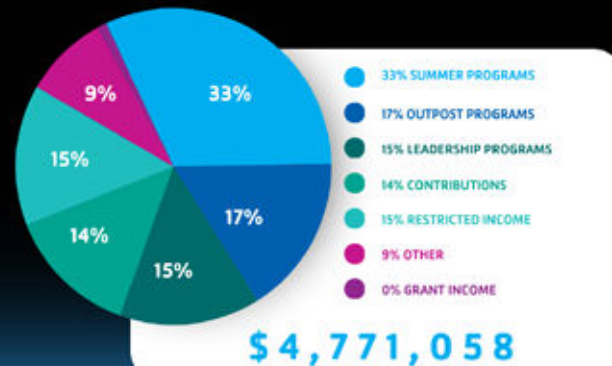
Camp Manitowish YMCA, Inc. is a 501(c)3. Financial information is based on our audited financial statements as of October 31, 2023; which are available upon request.

We have provided comparative graphs from 2023 to 2022. The graphs below show the percentage breakdown of total revenues and expenses by category for the fiscal year-ends October 31, 2023 and 2022. The biggest increase in the total expense dollars was Camp programs including salaries, benefits, and training which went from 34% to 39% of the expenses. This is due to the implementation of the second year, a 20% increase on average, of the planned doubling of seasonal staff salaries. The last year, FY2024, will be another 20% on average increase.
